S.O. 147.— In exercise of the provisions of Section 14 and 20 of the Disaster Management Act, 2005 and in supersession of all previous orders the Lt. Governor of Union Territory of Ladakh is pleased to constitute Ladakh Disaster Management Authority and State Executive Committee, Ladakh Disaster Management Authority


